Dr. Andreas S. Weigend has a unique career as a scientist, entrepreneur, and strategist in the areas of analytics and finance. He is an international authority on data mining and time series prediction. He has held several full-time professorships, most recently at New York University's Stern School of Business. He has published more than one hundred scientific papers and co-authored six books. He has also received numerous prizes including an IBM Partnership Award and a National Science Foundation Career Award. Dr. Weigend is a sought-after speaker at international conferences. He recently chaired the Forum on Behavioral Analytics in Brokerage and Banking, and organized the Sixth International Conference on Computational Finance, both in New York.

Dr. Weigend is a partner at Weigend Associates LLC, a high-end consultancy dedicated to developing technology-enabled information products. The firm generates intellectual capital, identifies and transfers academic research to business, and creates strategies for data-intensive organizations. Projects include trading models currently used by a major financial firm in Boston, as well as business and product strategies for China's first credit bureau. Clients include Acxiom, Goldman Sachs, J.P. Morgan, Morgan Stanley, Nikko Securities, Union Bank of Switzerland, and Yahoo.

Dr. Weigend has started several Silicon Valley high-tech companies. Most recently, he was Chief Scientist at a market data analysis firm backed by D.E. Shaw, Deutsche Bank, and others. Under his leadership, the company created information products based on behavioral finance, using state-of-the-art statistical techniques. In addition, he serves as advisor to several start-ups and venture capital firms. Dr. Weigend received his Ph.D. from Stanford University in physics. He was a post-doctoral research fellow at Xerox PARC (Palo Alto Research Center) and the Santa Fe Institute. He studied at Trinity College, Cambridge (U.K.), Bonn University, and Karlsruhe University (Germany).
